Lodging Policy

We do our very best to make your pet's stay with us a pleasant one. Our lodging fee includes the best quality environment away from your home that is available in this area. All pets are fed Hills pet food, provided fresh water constantly, housed in a modern environmentally controlled facility, and kept in spacious individual lodging facilities. All large dogs are kept in stainless steel runs that are unique in this area because they have a soft padded run. In OUR facilities, your pet is NEVER kept on a COLD, WET, or CONCRETE FLOOR!!! Your pet is walked in a fenced yard three times daily for exercise and to relieve himself or herself. Cats are placed in a clean cage and provided with fresh litter, food and water daily. Every pet receives individual attention from our FULL-TIME kennel staff dedicated to providing the best care possible.

All animals presented to this hospital for lodging must have current immunizations. You, as the responsible owner, must provide written proof of these vaccinations from a licensed veterinarian or we can administer the vaccinations or testing for your convenience at the time of lodging. If your pet needs to be tested for intestinal parasites and is positive he/she will be dewormed while staying with us. This not only protects your pet, but also provides protection for other animals that are in this hospital. Lodging requirements listed below (annual examination with one of our doctors - current within a year)

Canine: Examination, Rabies Vaccination, Distemper Vaccination, and bi-annual Kennel Cough and a negative Fecal.

Feline: Examination, Rabies Vaccination, Distemper with Leukemia Vaccination, Felv/Fiv Test and bi-annual negative Fecal.

After lodging for 3 consecutive nights, your pet will receive a **complementary bath** the morning of the scheduled discharge date unless you decline this service. If upon admission we notice that your pet has fleas or ticks we will apply an oral and/or topical treatment for this and the fee for the treatment will be added to your bill for this service. In the event that your pet becomes ill for any reason during their stay with us, we will provide immediate medical care for them and your signature below is your consent for the same.

Lodging pets will not be released before noon on any day unless special arrangements have been made in advance.

Boarding your pet provides a good opportunity to request any special services your pet might need-such as lab test, teeth cleaning, comprehensive physical examinations, spay/neuter etc. Please do not hesitate to discuss any possible treatments, surgical procedures and/or problems with us. If there is anything special that we can do for you and/or your pet to help make this stay with us more pleasurable, please let us know and indicate in the space provided below.

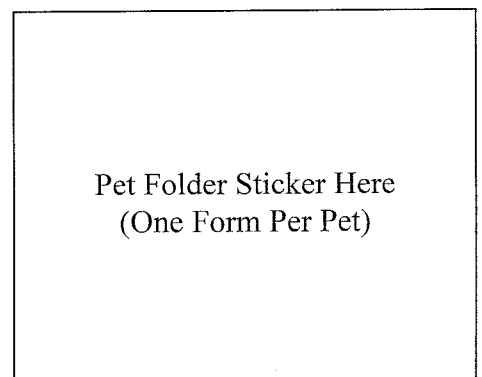
